### CALENDAR OF ACTIVITIES

Here is a brief look at the various activities undertaken by Adaptation Knowledge Platform (AKP) and Asia Pacific Adaptation Network (APAN) in April.

5th Bi-Monthly Seminar on Public Awareness, Behavior Change and Calls to Action for Sustainable Consumption & Production: The Role and Responsibility of the Media, Entertainment & Creative Industries in Adapting to Climate Change in Bangkok, Thailand, 27 April



The workshop explored how partnerships with international development and donor agencies as well as private sector companies can affect issues such as climate change by encouraging mass awareness of green consumption. It also examined ways to enhance communication and strengthen the capacity of civil society organizations and the mass media to influence environmental governance in Southeast Asia. The workshop included a panel of professionals who demonstrated the use of media relationships and tools for advocacy, awareness and behavior change in accomplishing sustainable development. Efforts to engage the media and the entertainment and creative industries facilitated the cultivation of an enlightened consumer and public opinion, which can exert direct and indirect pressure on decision makers. The seminar was organized in partnership with Sida/Swedish Environmental Secretariat for Asia (SENSA), Thailand and the Media Alliance, Singapore. #### 1st Follow-up Meeting on Web Portal-Based Climate Change Adaptation Knowledge Management Partnership, Pathumthani, Thailand, 19 April

The meeting started off with brief introductions by the representatives of Mangroves for the Future (MFF), Sustainable Development in the Context of Climate Change (SDCC), Asian Development Bank (ABD), Rockefeller Foundation and the Adaptation Knowledge Platform. The meeting aimed to provide the partners a platform on which they could give an insight into the climate change adaptation knowledge management systems that have been established or are in the process of development. It also provided the Adaptation Knowledge Platform an opportunity to introduce its partners to its web portal in terms of its use and current functions, and technical requirements for potential linkages.

The partners were also given a demonstration on how to use the web-portal. They were informed that they could either upload the information on the web-portal directly or linkages could be set up between their portals and that of Adaptation Knowledge Platform. The participants went back with a better understanding of the knowledge management systems, use of the web-portal and the steps required for the successful completion of this project. The meeting came to a close with all the participants promising to take the project to the next level.



#### Bhutan Mission, 20-22 April

The Adaptation Knowledge Platform undertook a mission to explore and scope adaptation knowledge management (AKM) activities and share information on the Asia Pacific Adaptation Network. Possible engagements discussed were joint seminar on mountain ecosystems, Bhutan Climate Summit in October 2011 and capacity building activities. Prioritizing AKM planning and processes within the National Environment Commission (NEC) through the NAPA process was another point of deliberation.

### COLLABORATIONS AND PARTNERSHIPS

## 5th International Conference on Community-Based Adaptation (CBA) to Climate Change, Dhaka, Bangladesh, 24-31 March

The Adaptation Knowledge Platform spearheaded the session on "Community Based Adaptation (CBA) Knowledge Management" at the 5th International Conference on CBA. The session was chaired by Mr. Mozaharul Alam, Regional Climate Change Coordinator, UNEP Regional Office for Asia and the Pacific. The overall aim of the session was to share various ways for effective engagement of different stakeholders (suppliers and users) to generate and disseminate adaptation knowledge with special focus on community-based adaptation. The session also focused on several questions such as who needs adaptation knowledge, its various types; how to enhance collaboration, effective engagement and interaction between the two broader categories of adaptation practitioners (suppliers and users) to generate and disseminate knowledge; how to improve knowledge-sharing mechanisms and their effectiveness.

Ms. Roopa Rakshit, Senior Knowledge Management Officer of the Adaptation Knowledge Platform, shared knowledge management initiatives and activities of the Adaptation Knowledge Platform and the Asia Pacific Adaptation Network (APAN). She emphasized that since there is a proliferation of adaptation knowledge platforms and networks, there is an increasing need to strengthen coordination and collaboration. This is critical not only for the sake of using limited resources more efficiently, but also to provide comprehensive knowledge services with high quality and depth. As a first step, it is important to identify the areas of overlap, gaps and synergies. She also shared the key outcomes, thoughts, and reflections from the recently concluded Adaptation Knowledge Management (AKM) workshop in Bangkok, which aimed at promoting dialogue and improving the exchange of knowledge, information, and methods within and between countries on CCA, and to link existing and emerging initiatives. The AKM workshop was attended by around 30 global, regional, national and sub-national KM stakeholders.

Dr. SVRK Prabhakar, on behalf of IGES and APAN, was the chair for one parallel session on "Frameworks for Measuring Adaptation: Alternatives to Quantitative Approaches". The session focused on evaluation of adaptation and CBA. It also dwelt on frameworks for assessing adaptive capacity at local level, for measuring the progress in institutional mainstreaming of adaptation, and for planning, monitoring and evaluating the integration of disaster risk management, climate change adaptation and development.

## SYNTHESIS REPORT: ADAPTATION KNOWLEDGE MANAGEMENT WORKSHOP: HARNESSING ADAPTATION KNOWLEDGE IN THE ASIA-PACIFIC REGION

The report showcases the findings and recommendations at the Adaptation Knowledge Management Workshop, which was held in Bangkok, Thailand, on 28 February. It notes that though knowledge management practices are becoming dynamic and timely, challenges still exist around knowledge generation, and its integration into decision-making processes at all levels of society, and across sectors.



The workshop aimed at identifying knowledge partners to link regional climate change adaptation knowledge through a knowledge sharing system that promotes dialogue and improves the exchange of knowledge, information, and methods within and between countries besides linking existing and emerging networks and initiatives.

The workshop invited Information & Knowledge Focal Points to take stock of adaptation knowledge relevant to the Asia-Pacific region, highlight good practices and lessons learned, identify guidelines, and ways to strengthen information exchange amongst a diverse range of adaptation stakeholders. They include vulnerable communities, donor organizations, implementing agencies, national and regional research institutions, knowledge intermediaries/ knowledge brokers, and the private sector.

#### LGUs training to pave the way for BRFAP, Philippines, 26-28 April

The Climate Change Academy-Center for Initiatives on Climate Adaptation (CIRCA), Philippines is conducting a 3-day training designed for capacity development and formulation for the Bicol Regional Framework and Action Plan (BRFAP) on disaster risk reduction and climate change adaptation. Participants are local government units (LGUs) across the Bicol region, who will work to enhance their senior technical staff's capabilities through localized knowledge management in climate change and by the integration of disaster risk reduction as well as adaptation strategies.

#### Lessons for Future Action, Apia, Samoa, 23-26 May 2011

Lessons learned from climate change adaptation and disaster risk reduction in small island developing states.

The Lessons for Future Action Conference will bring together experts from the Pacific, the Caribbean, Indian Ocean and elsewhere to examine how lessons learned can inform future climate change adaptation and disaster risk reduction in small island developing states.

This conference will consider Small Island Developing States (SIDS) experience and lessons learned in light of:

- the many similarities in reducing the risks of natural disasters and early adaptation measures
- the implications of 'tipping points' for natural systems, such as coral reefs
- the iterative nature of adaptation which will require `learning by doing' and flexible approaches as understanding of the likely timing and magnitude of climate change impacts improves
- the risks of mal-adaptation and the need for monitoring and assessment of adaptation responses so adjustments can be made over time

- common themes and challenges, and examples of good and not-so-good practice emerging from early adaptation activities, including community based adaptation, and
- what is needed to effectively communicate climate change to a variety of stakeholders.

#### Threatened Island Nations: Legal Implications of Rising Seas and a Changing Climate, 23-25 May, Columbia University

The Center for Climate Change Law and the Republic of the Marshall Islands are co-sponsoring a conference, "Threatened Island Nations: Legal Implications of a Changing Climate". The meeting will discuss such issues as continuing statehood and maintenance of maritime zones for states facing inundation from sea level rise; resettlement rights and practicalities of population displacement; liability for climatic harm in judicial forums; the utility of responsibility regimes under current law; and the role of a new convention on climate displacement.

#### Integrated Water Resource Management in the Mediterranean: Dialogue toward New Strategy, 20-22 June, IAV Hassan II, Agadir, Morocco

The strategic objective of this event is to contribute to the improvement of regional water planning and management under scarcity conditions to enhance sustainable development in the Mediterranean region. It also aims to foster dialogue and communication among its 46 partners.

## Bangladesh NGOs Network for Radio and Communication (BNNRC)

Fourteen community radio (CR) stations in the country are working in different communities/geographic regions manned by 13 NGOs and one government agency. The broadcasting approach of the network is purely bottom up. All the stations are situated at very natural disaster prone remote areas and programs relay the voices of the vulnerable people to the policy level.



#### Profile

#### International Climate Champions, 2010 - 2011

The International Climate Champions initiative is part of a range of activities by the British Council to build understanding about climate change. This oneyear program for the youth helps them influence and educate their peers about the urgency of adapting to climate change.

In 2008 the program was launched in 13 countries of Brazil, Canada, China, France, Germany, India, Italy, Japan, Mexico, Russia, South Africa, the United Kingdom and the United States, and then grew to encompass more than 800 International Climate Champions in 29 countries. In 2009, the program expanded to 60 countries across the globe, recruiting over 1,300 young people who are passionate about and committed to taking action on climate change. These champions are not only leaders in their communities but are also participating in international peer networks, both in person and online, to share ideas, projects and experiences.

International Climate Champions from Asia included participants form Nepal, Bangladesh, India and Sri Lanka. In Bangladesh, 16 international climate champions were chosen from 217 project ideas.
