CALENDAR OF ACTIVITIES

Synthesis Workshop of the Research and Knowledge Generation Components of AKP Held

During 12-13 December 2011, the Regional Climate Change Adaptation Knowledge Platform for Asia (AKP) held "Connecting the Dots: A Synthesis Workshop of the Research and Knowledge Generation Components



of AKP" at the InterContinental Hotel Conference Center in Bangkok. This workshop shared the key findings and lessons learned from the scoping, pilot and research activities conducted by AKP on the practice and implementation of climate change adaptation (CCA) across the South and Southeast Asia regions. National partners from Bangladesh, Bhutan, Laos, Nepal, Thailand and Viet Nam attended the workshop.

So far, AKP has conducted 11 scoping studies and conducted pilot activities in Viet Nam and Thailand. Preliminary activities were done in Cambodia. AKP has also conducted research on understanding adaptation planning in Nepal,

Philippines and Viet Nam; a comparative study on the difference between adaptation and development in Bangladesh and Viet Nam; and, the policy context of adaptation in Bhutan, Nepal, and Thailand.

The objective of the pilot activities was to support the pilot countries in strengthening their capabilities to introduce effective adaptation measures into policies and plans at the national sub-national and local levels. In many countries the planning process is sector and based under individual ministries. Therefore, planning is fragmented. A cross-sector approach to planning is needed, but more often than not neglected. Furthermore, planned adaptation responses tend to be centrally directed. Therefore, there is a need for two-way communication and collaborative relationships between service providers and recipients.

A key finding from the scoping studies was that knowledge and practice are separate entities. The actors belonging to the two components differ and have different priorities and ways of working. In effect "they speak different languages". An important challenge for AKP is to bring these two groups together. In the research on understanding planning, two key insights are worth sharing:

Adaptation is not just an activity; it is also a way of looking at all the components of development planning
from a climate risk-perspective. Both case studies acknowledged strong links between natural resource
management and climate change adaptation planning. For example, in Nepal, communities were already
adapting to climate change and developing more resilient livelihoods. Both studies also identified the
importance of involving stakeholders in planning processes, especially those communities affected by
climate change, and hence, the value of a bottom-up approach.

• The community-based disaster risk reduction and management approach presents a strong framework on which to base the planning and implementation of adaptation in Nepal. Meanwhile, in Viet Nam community based approaches to DRM are also being introduced, these also offer an opportunity to introduce CCA planning. However, constraints to greater community participation still exist. For instance, despite the existence of developed community-based structures in Nepal, local elites still tend to dominate the decision-making and planning process, whilst other constraints include institutional conflicts. The studies also showed the risks of looking at adaptation in isolation, and its lack of integration with other sectors, which can often lead to unsustainable adaptation or "mal-adaptation".

The findings from the study on the policy context of adaptation suggest that the policy making process is dependent upon an institution's or individual's capacity to understand and use information effectively to enforce the policy. The success of policy implementation is also dependent on an enabling environment. Enabling factors, include legal acts which enforce the policy, adequate financing, a strong NGO presence in the policy formulation process, and a high-level of public awareness concerning CCA and the policy making process. The value of effective communications and the sharing of knowledge, data and policies to policy implementers was also recognized; this is related to how information can be delivered effectively, so implementers can easily understand the policies.

Finally, based on the comparative study of adaptation and development in Bangladesh and Viet Nam, discerning between adaptation and development projects and programs is still a challenge one that was recognized by many of those interviewed. In addition, and within each country, there were differences in stakeholder priorities to consider.

Forthcoming Activities

Southeast Asia Climate Change Focal Points and Experts Consultation Meeting, February 8- 9, 2012 Manila, Philippines

The 'Southeast Asia Climate Change Focal Points and Experts Consultation Meeting' is scheduled to be held in Manila, Philippines from February 8 to 9 as a back to back event to the "APEC Symposium on Climate Change" that will kick-off from February 6 to 8 2012. The meeting will be organised by APAN in collaboration with UNEP and Local Governments for Sustainability (ICLEI) with the objectives a) to introduce UNEP networking approach including APAN to climate change focal points and experts as well as the APAN sub-regional nodes and thematic nodes to the key stakeholders, b) identify potential national institutions for the network and their roles to respond in collaboration with APAN, c) identify concrete trainings on climate adaptation in the region based on the already identified needs for climate adaptation in the region, d) identify priority regional issues, support needs to overcome those challenges, and e) operationalization of APAN activities in Southeast Asia. The consultation meeting aims at bringing together the government officials, INGO/ NGOs, development practitioners, academicians and individuals working on or interested in CCA.

International Training on Climate change mitigation and adaptation, February 10-11, Manila, Philippines

An international training on 'Climate change mitigation and adaptation' will be held in Manila, Philippines from February 10-11, 2012 which will be co-organised by APAN, UNEP and the Local governments for sustainability (ICLEI). The training aims to enhance the understanding of national and local governments on climate issues at local, national and global level and thus improve their capacity in adaptation and mitigation planning for climate change. The objectives of providing conceptual clarities on the impacts of climate change and ways to address these impacts while introducing different dimensions and approaches of climate change adaptation including the different measures and mainstreaming approaches is intended to be achieved through experts' presentations.

NEW DATES OF THE SECOND ASIA-PACIFIC CLIMATE CHANGE ADAPTATION FORUM, MONDAY, 12 & TUESDAY, 13 MARCH 2012

2nd Asia-Pacific Climate Change Adaptation Forum

The Second Asia-Pacific Climate Change Adaptation Forum, which had to be put off due to the alarming flood situation in Bangkok in October, will now be held at the United Nations Convention Centre (UNCC) from 12 to 13 March 2012.

The interactive Forum aims to focus on "Adaptation in Action" signifying a shift from deliberations to decisions, plans to policies, and from policies to practices.

Confronted with the threat of flooding, the Forum, earlier scheduled from October 27 to 28, 2011, had to be postponed at the last minute. Bangkok was in the grip of floods, which had led to the closure of the UNCC, besides prompting the Thai Government to declare a long holiday on days that coincided with the dates of the Forum.

We hope the deliberations at the Forum, which will gather leading adaptation practitioners from across the globe, will help put behind us this painful chapter in the history of Thailand.



The format of the Forum will remain the same, with a diverse range of plenary and keynote sessions, panel discussions, roundtables, thematic events, market place and film festival. Sessions will be facilitated by eminent climate scientists, adaptation experts and development planners from the region.

The Forum will focus on:

- 1. Linking knowledge to adaptation actions;
- 2. The governance of adaptation decision-making;
- 3. Insights from practices Learning from experiences on the ground.

Some sessions will focus on key sectors or areas vulnerable to the impacts of Climate Change impacts whereas others will deal with issues that cut across sectors and places. These broad themes will be discussed in the context of sustainable development, and with the objective of stimulating concrete and practical actions that will impact the most vulnerable ecosystems and societies.

The Adaptation Forum is being organized by the Regional Climate Change Adaptation Knowledge Platform for Asia (Adaptation Knowledge Platform), the Asia Pacific Adaptation Network (APAN) and the Asian Development Bank (ADB).

e-discussion on Strengthening Research Capacity of HKH universities, Kathmandu, 2–12 Jan

The Himalayan University Consortium (HUC), a membership-based network for promoting education, research and capacity building, and training for sustainable mountain development of HKH region, which covers many large, vulnerable, and fragile ecosystems in Afghanistan, Bangladesh, Bhutan, China, India, Myanmar, Nepal, and Pakistan, held a series of e-conferences in Kathmandu from January 2 to 12. This was a run-up to meetings of two dozen vice-chancellors and other university representatives from the region later in the month. The e-discussions focused on how HKH universities could adopt a more socially and economically relevant and inclusive agenda for knowledge development and dissemination, and the kinds of institutional changes required to target knowledge development in support of poor and marginalized communities.

NCCKMC (NAST-CDKN) Climate Change Policy Dialogue and Consultation, Kathmandu, 4 Jan

Nepal Climate Change Knowledge Management Center (NCCKMC) successfully organised a Policy Dialogue and Consultation on Climate Change in Kathmandu. Minister for Science and Technology Kalpana Dhamala declared the programme open amidst a gathering of over 130 participants representing 33 institutions working on climate change issues. Minister Dhamala underlined the need to devise adaptation tools to cope with the adverse effects of climate change and generate science-based knowledge for its long-term solution. In the context of Nepal, she urged the experts to come up with plausible adaptation models to protect vulnerable groups, especially women in the rural areas. The programme was chaired by Vice-Chancellor of Nepal Academy of Science and Technology Professor Surendra Raj Kafle.

Himalayan Universities to Join Hands on Knowledge Generation, Kathmandu, 23-24 Jan

Universities and research institutions working in the mountain and hilly regions of Bangladesh, China, India, Nepal, and Pakistan have agreed to work together as a network for mountain-focused teaching, research, and outreach in the Hindu Kush-Himalayan (HKH) region. This collaboration was cemented at a conference of more than two dozen vice-chancellors, deans, professors, and researchers held at the headquarters of the International Centre for Integrated Mountain Development (ICIMOD). The conference was convened by the

ICIMOD-based Himalayan University Consortium (HUC), with financial support from the Canadabased International Development Research Centre (IDRC). In the opening address, Dr David Molden, Director General of ICIMOD, spoke of ICIMOD's readiness, as a regional knowledge and learning organization, to work with the universities to generate new knowledge and technical solutions to address challenges of climate change, poverty, and environmental degradation in the region.

Workshop on Building Resilience with Common Capital, Tokyo, 23-25 Jan

APN, DIVERSITAS, International Human Dimension Programme on Global Environmental Change (IHDP) and United Nations University-Institute for Sustainability and Peace (UNU-ISP) held a workshop on "Building Resilience with Common Capital: Managing Shared Resources, Meeting the Challenges of a Rapidly Modernizing World under Climate and Ecosystem change", in Tokyo. National and local governments and private institutions in the Asia-Pacific region are expected to develop new sustainable ecosystem and rural landscape management policies and measures as an output of this workshop. Lessons from Sub-Saharan Africa

All about Monitoring and Evaluation

A report titled "Monitoring and Evaluation for Adaptation: Lessons from Development Cooperation Agencies" is the first empirical assessment of M&E frameworks used by development cooperation agencies for projects and programmes with adaptation-specific or adaptation-related components. It analyses 106 project documents across six bilateral development agencies. Based on this, it identifies the characteristics of M&E for adaptation and shares lessons learned on the choice and use of indicators for adaptation. This report is an output of the OECD Task Team on Climate Change and Development Co-operation, which is overseen jointly by the Working Party on Global and Structural Policies (WPGSP), predecessor to the Working Party on Climate, Investment and Development (WPCID) of the Environment Policy Committee (EPOC) and the Network on Environment and Development Co-operation (ENVIRONET) of the Development Assistance Committee (DAC).


On Resolving the Food Crisis

While the 2007-08 food price crisis has been a catalyst for important policy reforms, governments have yet to address its underlying causes, finds a new report from IATP and the Global Development and Environment Institute (GDAE) at Tufts University. In the report titled "Resolving the Food Crisis: Assessing Global Policy Reforms Since 2007", authors Timothy A. New Working Paper on Responses to Climate Change Among the Urban Poor in Khulna

The ClimUrb research programme at the Brooks World Poverty Institute, the University of Manchester, UK, has produced a new Working Paper titled "Community and institutional Responses to the Challenges Facing Poor Urban People in Khulna, Bangladesh in an Era of Climate Change' by Manoj Roy, Ferdous Jahan and David Hulme. This paper focuses on a private and a public settlement within Khulna City, Bangladesh, to identify the challenges facing
