## Asia Pacific Adaptation Network A regional programme to manage and apply adaptation knowledge: Consolidating the best of two initiatives

The Regional Climate Change Adaptation Knowledge Platform (AKP) was launched in 2008 as a partnership between United Nations Environment Programme (UNEP), Regional Resource Centre for Asia Pacific (RRC.

AP), a centre at the Asian Institute of Technology collaborating with UNEP, and the Stockholm Environment Institute (SEI). It operated through a secretariat based in RRC.AP, and implemented activities in partnership with key centre of excellences and actors. The Adaptation Knowledge Platform was supported by the Swedish International Development Cooperation Agency (SIDA) through the Swedish Environmental Secretariat for Asia (SENSA).



The Asia Pacific Adaptation Network (APAN) was launched by the Prime Minister of Thailand

in October 2009 as the first region-wide adaptation-specific network as a part of the Global Adaptation Network (GAN). APAN was facilitated by UNEP Regional Office for Asia and the Pacific (ROAP), and operated through a Regional Hub, jointly hosted by the Institute for Global Environment Strategies (IGES) and Regional Resource Centre for Asia Pacific (RRC.AP), in partnership with key centre of excellences and actors. Ministry of Environment Japan (MoEJ), Asian Development Bank (ADB) and Swedish International Development Cooperation Agency (Sida) provided it financial support right from its inception.

## **APAN: Consolidating the best of both initiatives**



AKP and APAN have been tackling the increasingly important region-wide task of documenting and disseminating climate change adaptation knowledge, and supporting the application of knowledge at different levels. In 2011, a joint retreat of AKP and APAN led to the decision of merging the two initiatives to deliver benefits to the region more effectively and sustainably. The ultimate aim of the consolidated initiative is to build climate change resilient, gender-sensitive and sustainable human systems, ecosystems and economies through the mobilisation of knowledge, enhanced institutional capacity, informed

decision making-processes, and facilitated access to finance and technologies. It lays special emphasis on the management of knowledge and capacity building. The name of the new initiative will continue to be APAN.

UNEP Regional Office for Asia and the Pacific (ROAP) will manage APAN, which will operate through a Regional Hub and Core Technical Partners, namely Institute for Global Environment Strategies (IGES), Regional Resource Centre for Asia Pacific (RRC.AP), and the Stockholm Environment Institute (SEI). Partnership with key centres of excellences and actors at sub-regional levels will be a major vehicle to reach and support adaptation actors in government, civil society and business communities.

The united face with more number of core partners, a new logo and web portal (http://www.asiapacificadapt. net/) will be in effect from January 2013. The existing individual website of APAN and AKP will cease to exist and be automatically redirected to the new web portal. The revamped web portal will be available from January 2013 with new features, including an online community of practice, and will continue to be an interactive means for sharing information and knowledge on climate change adaptation and on building adaptive capacities in Asian and Pacific countries.

## CALENDAR OF ACTIVITIES

International Conference on Climate Change Impacts and Adaptation for Food and Environmental Security, Nov. 21–22, 2012, SEARCA College, Los Baños, Laguna, Philippines

This conference called for new ways of tackling climate change challenges by using various climate change models and tools to understand the potential impacts on food and environmental security. It also served as a venue for promoting partnerships and linkages among different sectors for collaborative capacity development and research.



It concluded by calling for greater collaborations across agencies (public and private; local, national, and global scales) in Research and Development (R&D) and/or education sectors. It also underlined the importance of mainstreaming research findings in Science and Technology (S&T) in the local and national governance system to ensure sustainability of the networks.

## Sub-annual Conference on Multi-stakeholder Dialogue on Adaptation to Climate Change in Central Asia Facing COP 18 to the UNFCCC, Nov. 12–13, 2012, Tashkent, Uzbekistan

The **objectives** of the sub-annual conference were to facilitate a sub-regional multi takeholder dialogue on the priority adaptation measures and technology needs in water and agricultural sectors in Central Asia; and assist Central Asian countries in developing joint multi-stakeholder messages in preparation to the 18th session of the Conference of the Parties (COP 18) to the UNFCCC, Qatar.

**The conference identified** some of the regional priorities for adaptation in the region and underlined the need for more capacity building on adaptation besides further studies and research, and development of a regional strategy on adaptation in different sectors.

# Training and Consultations among South Asian Policy Makers on National Adaptation Plans (NAPs), Nov. 5–6, 2012, Kathmandu, Nepal

The **objectives** of the training workshop were to share best practices for National Adaptation Plans (NAPs), and map key sectors that need to be prioritized in respective countries.

**The workshop concluded that** more training workshops to build capacity of the countries on NAPs were required as there was still some confusion regarding NAPAs and NAPs, the eligibility criteria, and proposal preparation for NAPS. It also sought more training on cross-ministerial coordination and cooperation.

# Pacific Climate Change and Financing Training Workshop, Oct. 25–26, 2012, Apia, Samoa

**The objectives** of the training workshop were to increase general understanding about specific donors and the types of climate change financing available to the Pacific countries; familiarize participants with the individual donor policies and financing criteria; and teach them how to write proposals, and meet the monitoring, evaluation, and reporting requirements of the donors.

**The workshop concluded that** more training workshops should be held to build capacity of the countries on climate financing and there should be more frequent dialogue between countries and donors to facilitate easier accessibility to climate funds.

# Training on Climate Change Adaptation Planning, Sept. 21–22, 2012, Kuala Lumpur, Malaysia

**The objectives** of the training were to provide general concept on impacts and vulnerability of climate change, and adaptation; discuss different approaches to adaptation at regional and national levels; provide examples of adaptation technologies in vulnerable sectors and areas; and share current approaches and methodologies for mainstreaming and integrating adaptation into national and local planning processes.

**Six sessions to meet the training objectives outlined above concluded that** there was need for more cross-sectoral training on climate adaptation besides better coordination between the different government departments.

#### **Climate Talks Adopt Gender Balance Goal**

The COP18 in Doha adopted a "gender balance" goal with the aim of increasing w o m e n ' s participation in the negotiations, with experts hoping



that this will make climate change policy more responsive to women's needs. The goal, which was adopted at the end of the fractious conference, said that the almost 200 nations involved in the talks need to make additional efforts to improve the gender balance in the many bodies under the UNFCCC. It also asks them "to strive for gender balance in their delegations" at the talks. The conference asked the U.N. climate secretariat to organise a workshop at the next year's conference to boost women's involvement in the talks. ### Future Earth Regional Workshop for Asia and the Pacific, Nov. 21–23, 2012, Kuala Lumpur, Malaysia

The workshop was part of an initial regional round

of consultations to establish а framework on global sustainability. It was established The Science by and Technology Alliance for Global



Sustainability, which consists of a number of organisations, including International Council for Science, International Social Science Council, Belmont Forum, UN Educational Scientific Cultural Organisation, UNEP, and UN University, with World Meteorological Organisation as an observer.

The workshop was held over three days with a number of interactive sessions to discuss, challenge, regionalise and specify the initial design options of the global research framework for Future Earth, and the governance structure that an international transition team of experts has been working on. The workshop was a congregation of scientists, development actors, educators, capacity builders, funders and individuals working at the boundary between science and policy.

## Rockefeller Foundation Extends US\$1.75 Mn Grant to Expand Resilience Programme to 40 New Cities

The New York-based Rockefeller Foundation has extended a US\$1.75 million grant to allow up to 40 more cities in Asia to benefit from pilot urban climate change resilience initiatives developed by the Asian Cities Climate Change Resilience Network (ACCCRN). This marks the first ever effort to significantly scale up a large number of cities' ability and capacity to adopt new tools and resources for building urban climate resilience.

WOTR's first local weather specific agro-advisory was sent out at 5.14 pm on December 20, 2012 for the tomato growers of Warudhi Pathar and Sarole Pathar, Sangamner Taluka, for the control of red mites. The SMS advised the farmers to spray neem seed kernel extract (NSKE) to control the pesky mites which are the bane of every tomato farmer.

#### Regional Training Course on Paleoflood Hydrology in Flood Risk Assessment, Feb .18–22, 2013, Bangkok, Thailand

The Regional Integrated Multi-Hazard Early Warning System for Africa and Asia (RIMES) is organising a regional training course on Paleoflood Hydrology in Flood Risk Assessment, from February 18 to 22, 2013, in Bangkok. The training shall mentor participants in paleoflood data collection, analysis, management, and application in flood risk estimation. Paleoflood hydrology enables the generation of long-term flood record by reconstructing the magnitude and frequency of past floods in areas without flood-level observations, by using geomorphological indicators and documentary evidence. It is, thus, possible to quantify flood risks in areas with paucity in flood records, for developing flood risk management plans.

climate change. It highlights that the world's poorest people are increasingly bearing the consequences of unsustainable development; and explains that to




truly deliver upon sustainable development, any new development path must focus on ensuring equity and building resilience within the global economy, within countries and within local communities.





## India Case Study: Developing State-Level Action Plan

Launched in 2008, India's National Action Plan on Climate Change (NAPCC) outlines а national agenda for addressing climaterelated challenges through eight national missions. Accordingly, State Action Plans on Climate Change (SAPCC) are required to effectively ensure



that national objectives are aligned with regional development priorities and the local environmental context. The UNDP has partnered with the Government of India's Ministry of Environment and Forests (MOEF) and other stakeholders to develop a Common Framework for preparation of the SAPCCs. The Common Framework will enable a consistent methodology for identifying state priorities on climate change and a coherent approach to developing adaptation and mitigation options. The framework draws on guidance by UNDP on preparing Green, Low-Emission, Climate Resilient Development Strategies (UNDP 2011). The SAPCC developed in the Indian State of Madhya Pradesh (MP) illustrates the implementation of the process outlined in the Common Framework.

### A Systems Approach to Meeting the Challenges of Urban Climate Change

This article identifies the future challenges that cities face in their ability to create well-being, particularly for urban poor communities, as a result of the compound effect generated by climate change. It suggests that action to reduce exposure and improve the adaptive capacity of urban populations must simultaneously address disaster risk reduction, urban poverty reduction and urban resilience (i.e. the ability of the city to maintain the functions that support the well-being of its citizens). Based on evidence and experience from 10 cities which form part of the Asian Cities Climate Change Resilience Network (www.acccrn.org), this article proposes that a simplified conceptual model and resilience characteristics be used to analyse urban systems to target action at multiple levels to reduce exposure and improve the adaptive capacity of urban populations.
