Pioneering LAPAs as a community-led solution to climate change challenges in Pakistan

The Leadership for Environment and Development (LEAD) Pakistan has developed two local adaptation plans of action (LAPAs) for two districts in Pakistan – Muzaffargarh and Thatta – under its Climate Leadership for Effective Adaptation and Resilience (CLEAR) project. This aims to facilitate poor and vulnerable communities in adapting to adverse impacts of climate change in the country. In the process of the development of LAPAs, innovative bottom-up approaches for policy engagement and community planning have also been established.
